You will need to have completed the AAT Certificate in Accountancy Level 2 to sign up to this course. Applicants considering starting at level 3 without the AAT level 2 qualification must discuss this with the course manager before enrolling.

The course is assessed through a variety of exams.

You can apply for an Advanced Learner Loan or Higher Education Loan to help with the costs of your course if you are 19 or older and the course you are studying is an eligible Level 3, 4, 5 or 6 course. You can progress on to the AAT Diploma in Accounting Level 4 course at the college. Once all three levels of the AAT qualification have been achieved you will be a qualified accounting

technician and can apply for full professional membership of AAT as long as you can satisfy their work experience requirements. You may then consider continuing your studies to become a qualified accountant. Each of the professional institutes (ACCA, CIMA, ICAEW and CIPFA) accepts AAT qualified accounting technicians onto their programmes of study, and all offer exemptions.
