What's Covered:

The aim of the course is to offer you the opportunity to gain the skills demanded by employers in accounting and finance, whilst achieving an internationally recognised qualification that could ultimately lead to the full AAT (Association of Accounting Technicians) Accounting Qualification and full AAT membership.

You will attend the College on a full-time basis over one year. There will also be study time to enable you to consolidate the work carried out in lectures.

Assessment Information:

You are assessed against the standards of competence laid down by the AAT, you will need to achieve a minimum of 70 per cent in all of the computer-based assessments.

You learn through experiencing a varied programme which includes activities, solving simulated problems, lectures, group work, discussions and attempting past examinations. You will also be required to study away from lectures to ensure exam success. Alternative Level 3 qualifications in business and associated areas are also possible.
