

# Award in Leading the Internal Quality Assurance of Assessment Processes and Practice (QCF)



Course Level: Level 4

Campus: Newcastle

Subject Type: Care, Education, Nursing & Midwifery

## Course Overview:

This qualification equips individuals with the knowledge and skills needed to lead internal quality assurance activities effectively. Participants learn to evaluate assessment processes, provide feedback to assessors, and ensure compliance with relevant regulations and standards.

## What's Covered:

This qualification is intended for those who wish to gain an understanding of the principles and practices of internal quality assurance without any requirement to practice. Studying this course, you will develop skills, knowledge and understanding to enable learners to perform the role of an internal quality assurer.

This is a knowledge-only award for those who are starting their journey as an internal quality assurer, or for those who need to know about assessment practice but who are not currently practicing e.g. a starting point for aspiring internal verifiers or a professional development qualification for managers, HR or quality assurance personnel.

The course consists of three units:

Unit 401 is a knowledge only unit assessed by a written assignment and professional discussion. In addition you will be expected to attend theory days where you will gain the knowledge required. Theory days will be run at various times during the year.

Unit 402 and 403 will be conducted on a 1-1 basis and will vary according to your work role. In order to achieve this certificate you must lead the internal quality assurance processes within your department.

## Entry Requirements:

All applicants must hold a minimum Level 3 subject specific qualification relevant to the area they are Internally quality assuring. Also required is an assessor qualification such as TAQA Level 3 Certificate or V1. You must also demonstrate that you are working at L2 in literacy. In addition you must have access to at least two assessors and have a proven track record of assessing and quality assurance. Finally you will need a qualified Lead IQA to support you during the course.

## Assessment Information:

Attending theory sessions is mandatory. After that for up to 15 weeks, assessments will be through observations and tutorials.

## Fees and Financial Support:

If you are on state benefits or are on a low income you may be entitled to fee remission towards your course. \*This is at the Colleges discretion.
